Privacy policy statement in pursuance of Art. 14 of European Regulation No. 679/2016

Dear User,

this notice is to inform you about the processing methods of your personal data, as required by Art. 14 of European Regulation No. 679/2016, "General Data Protection Regulation" (hereinafter "GDPR").

DATA CONTROLLER

PURPOSE OF DATA PROCESSING AND LEGAL BASIS

We inform you that the personal data that you voluntarily provide will be processed solely in connection with the newsletter service, whereby we will send you news about our products, updated information about the company, any competitions held and events organised, in which you may be interested.

The processing of your data will be carried out upon your consent, after you have carefully read this information notice and ticked the relevant box. We remind you that consent is voluntary, but if you do not give your consent, we will be unable to provide you with the requested service.

In the event that optional data are required, you are free to refrain from communicating them, without this affecting the service or its availability.

TYPE OF DATA

We inform you that the processing will only concern the data we hold, i.e. name, surname and email address, which have been communicated to us by IFSE, Culinary Institute, following your consent to the transfer of the data to the sponsors of the cooking school.

PROCESSING METHOD

The processing of your personal data will be carried out by electronic means, in a manner strictly related to the purposes mentioned above. Specific security measures have been adopted to prevent loss of data, illegal or improper use and unauthorized access.

Data will be processed for the time necessary to achieve the purposes for which they were collected (sending of newsletter).

COMMUNICATION OF DATA

Your personal data may be communicated to company personnel, with particular reference to employees who deal with marketing activities and those who deal with the maintenance of electronic instruments, appointed and trained by Guardini S.p.A. in carrying out their tasks.

Your personal data may be communicated to any qualified external parties who provide the Data Controller with instrumental or other services for the purposes indicated above (hosting providers, computer companies), appointed, if necessary, Data Processors by the Data Controller. The updated list of Managers may always be requested from the Data Controller.



DISCLOSURE OF DATA

Your personal data will not be subject to dissemination, will not be transmitted or disclosed to third parties.

RIGHTS OF THE DATA SUBJECT

In relation to the above mentioned data processing, at any time you will have the right to revoke your consent to the processing of your personal data, to obtain confirmation of the existence of your personal data from the Data Controller, to know their content and origin, to verify their accuracy and request their integration, cancellation, updating, correction, transformation into anonymous form, transfer to another Data Controller or blocking of data processed unlawfully, and to oppose, in any case, for legitimate reasons, their processing.

Since you are subscribed to our newsletter, you will have the possibility to request at any time to unsubscribe from the service, through the "Unsubscribe" button at the bottom of each newsletter.

COMPLAINT TO THE COMPETENT AUTHORITY
